## CONDITIONS OF ENGAGEMENT

1. The balance of the agreed fee shall be paid to **DJS R US formally Adrenalin mobile DJ Promotions (DJSRUS)** in full 7 days before the show date as dated on the booking sheet.
2. The engagement fee is firm and shall not be subject to any variation except that in the event of a change in the client's requirements a revised fee may be determined by negotiation between the client and **(DJSRUS)**.
3. The client may ask the DJ to stay on past the original time specified for the playing of the last song. If this is the case a small fee *may* be charged subject to negotiation.
4. Cancellation of the booking shall be notified by the client to **(DJSRUS)** in writing and posted in sufficient time to be received by **(DJSRUS)** not less than (30) days prior to the date of the engagement.
5. The client will forfeit the deposit if a cancellation occurs in accordance to with condition 4.
6. In the event of the booking being cancelled less than (30) days prior to the date of the engagement, then the client will forfeit the deposit and **(DJSRUS)** reserves the right to claim the total amount of the fee should an alternative engagement for the artist on the date not be arranged.
7. It is the responsibility of the client to provide a safe surface for the disco console and the artist to work from. Relocation of the console during an event causing an interruption of the music will not qualify the client for a fee reduction.
8. It is the responsibility of the client to provide adequate protection for the artist's:
  - i. Equipment and
  - ii. Conveying vehicles(s) against unauthorized interference or removal of any of the artist's equipment from the time of the artist's arrival at the venue until the completion of the engagement. The engagement is not deemed to be completed until the removal of the artist's equipment within a reasonable time by the artist's agent.
9. It is the client's responsibility to monitor the behaviour of the patrons at the venue. We take no responsibility for any injuries that may occur to patrons from a result of dancing or any other activities. The client is to ensure the patrons DO NOT come into contact with the artists equipment.
10. In the case of the engagement or venue begin outside the greater metro area the client will be responsible to pay for the overnight accommodation at a Motel or if there is no Motel in the town, a close by Hotel for 2 DJ's.
11. **(DJSRUS)** undertakes to provide an artist from **(DJSRUS)** in the event of illness, accident or any unforeseen circumstance that the agreed artist cannot work, **(DJSRUS)** reserves the right to provide a substitute performer/artist. Should a substitute artist not be available within **(DJSRUS)**, it is agreed that the job can be done subcontracted to another performer/artist. Should an artist fall ill or have an accident during the performance the full fee is still payable. The client will take no litigation if a subsequent performer cannot be found within reasonable time before the performance. I.e. 24 hours prior to the event.  
No fee will be payable if an artist does not arrive at the venue due to accident or illness.  
Any deposit will be refunded if the circumstance in the previous sentence occurs.
